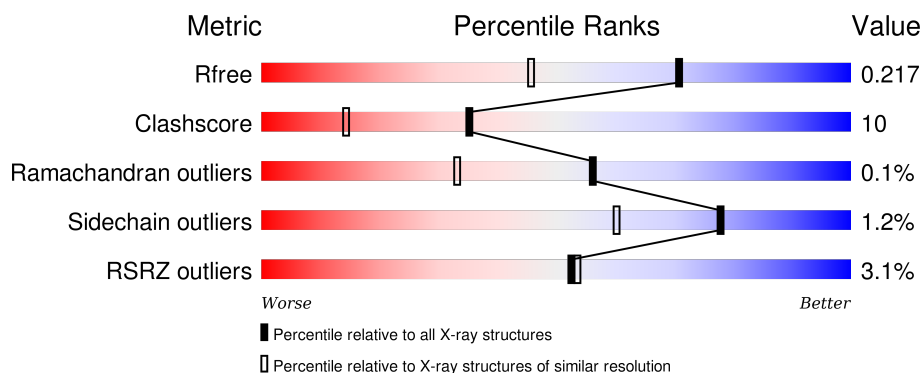
# 1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

## *X-RAY DIFFRACTION*

The reported resolution of this entry is 1.65 Å.

Percentile scores (ranging between 0-100) for global validation metrics of the entry are shown in the following graphic. The table shows the number of entries on which the scores are based.

The red, orange, yellow and green segments on the lower bar indicate the fraction of residues that contain outliers for  $\geq 3$ , 2, 1 and 0 types of geometric quality criteria. A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions  $\leq 5\%$ . The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

## 2 Entry composition

There are 2 unique types of molecules in this entry. The entry contains 7212 atoms, of which 0 are hydrogens and 0 are deuteriums.

- Molecule 1 is a protein called a2,3-sialyltransferase, a2,6-sialyltransferase.

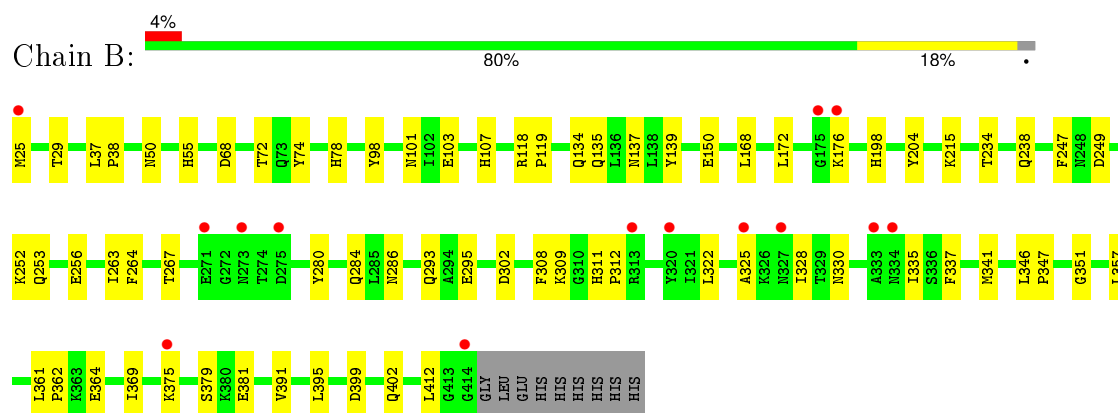
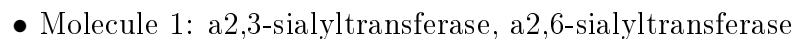

Xtriage's analysis on translational NCS is as follows: *The analyses of the Patterson function reveals a significant off-origin peak that is 73.80 % of the origin peak, indicating pseudo translational symmetry. The chance of finding a peak of this or larger height randomly in a structure without pseudo translational symmetry is equal to 1.7206e-06. The detected translational NCS is most likely also responsible for the elevated intensity ratio.*

<sup>2</sup>Theoretical values of  $\langle |L| \rangle$ ,  $\langle L^2 \rangle$  for acentric reflections are 0.5, 0.375 respectively for untwinned datasets, and 0.333, 0.2 for perfectly twinned datasets.

## 5 Model quality

### 5.1 Standard geometry

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with  $|Z| > 5$  is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).
