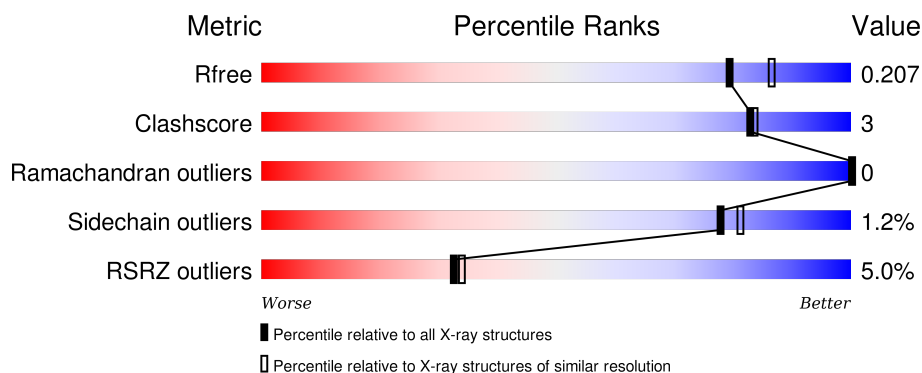
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

X-RAY DIFFRACTION


The reported resolution of this entry is 2.00 Å.

A grey segment represents the fraction of residues that are not modelled. The numeric value for each fraction is indicated below the corresponding segment, with a dot representing fractions $\leq 5\%$. The upper red bar (where present) indicates the fraction of residues that have poor fit to the electron density. The numeric value is given above the bar.

2 Entry composition

There are 6 unique types of molecules in this entry. The entry contains 4354 atoms, of which 0 are hydrogens and 0 are deuteriums.

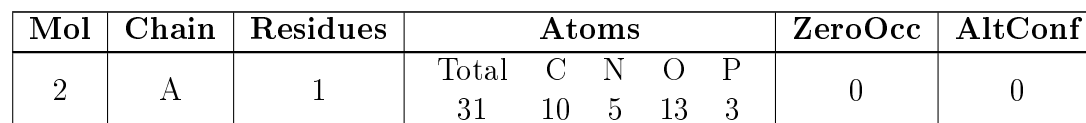

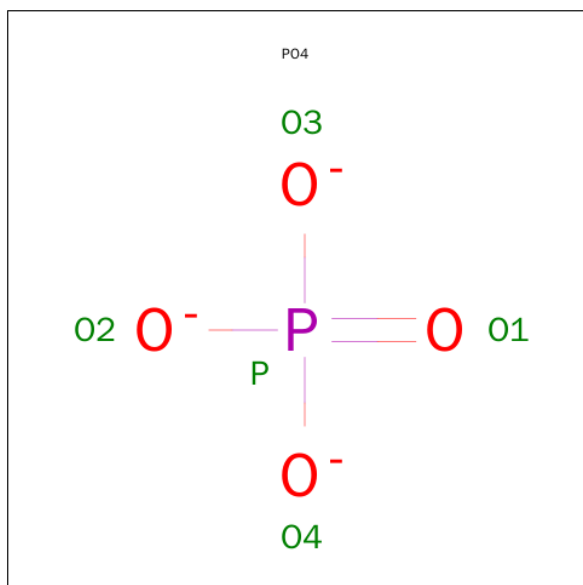

Xtriage's analysis on translational NCS is as follows: *The largest off-origin peak in the Patterson function is 3.74% of the height of the origin peak. No significant pseudotranslation is detected.*

¹Intensities estimated from amplitudes.

²Theoretical values of $\langle |L| \rangle$, $\langle L^2 \rangle$ for acentric reflections are 0.5, 0.375 respectively for untwinned datasets, and 0.333, 0.2 for perfectly twinned datasets.

The Z score for a bond length (or angle) is the number of standard deviations the observed value is removed from the expected value. A bond length (or angle) with $|Z| > 5$ is considered an outlier worth inspection. RMSZ is the root-mean-square of all Z scores of the bond lengths (or angles).

5.2 Too-close contacts [i](#)
