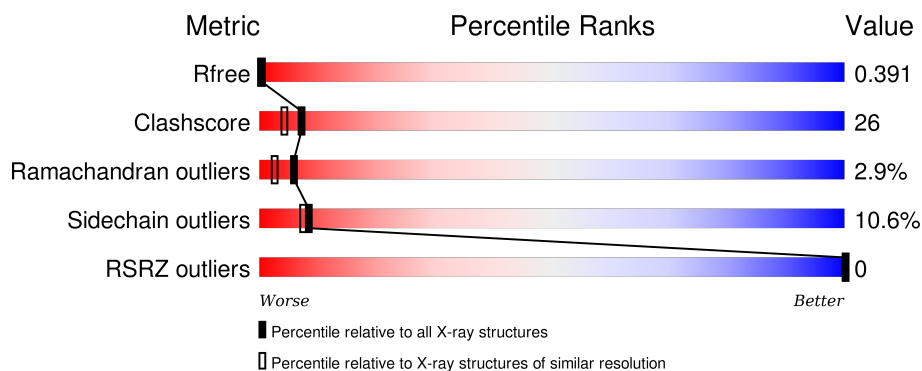
1 Overall quality at a glance

The following experimental techniques were used to determine the structure:

X-RAY DIFFRACTION


The reported resolution of this entry is 2.20 Å.

2 Entry composition

- Molecule 1 is a protein called HEAT SHOCK PROTEIN HSP 90-ALPHA.

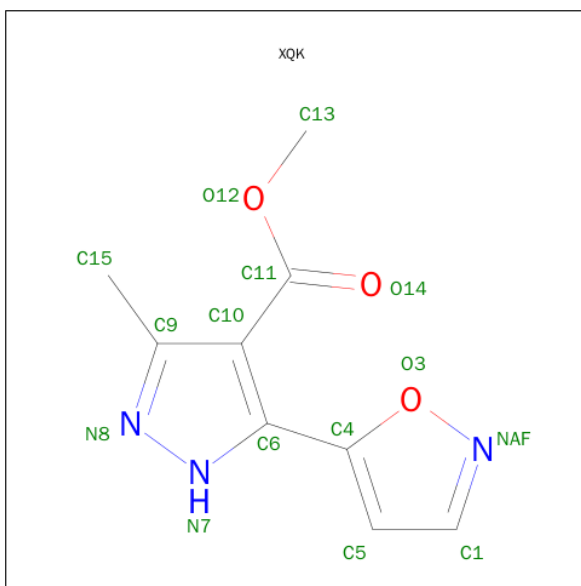

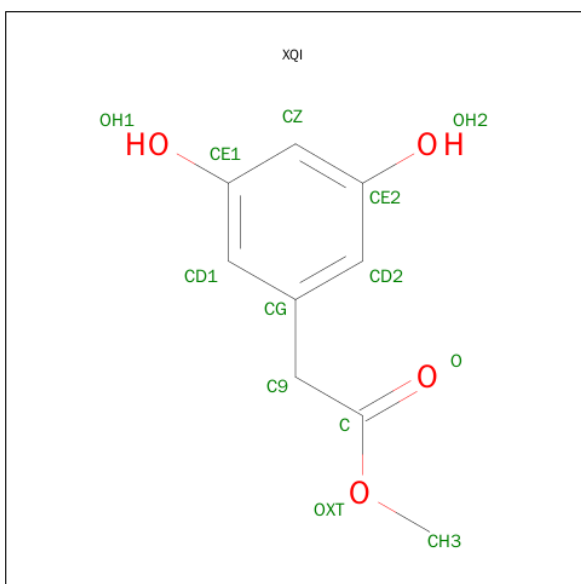
